NOTE

Under Internal Revenue Regulations, tax-exempt charitable organizations generally must provide requesters with COPIES of:

- Its approved exemption applications, all required attachments and any related correspondence with the IRS, and
- Its three most recent annual information returns (Form 990), including all schedules and attachments (but not the names and addresses of contributors).

In-person requests: *A member of the public may request to inspect the documents at any principal office of the organization. The entity must provide the information requested that same day. However, if the request places an “unreasonable burden” on the organization, the staff must provide copies of the requested information no later than the next business day after the unusual circumstances cease to exist (limited to a maximum of five business days after the request).*

Written requests: *Written requests made by fax, mail, email, or overnight service, which include the requester’s address, must be honored within 30 days of receipt.*

Website alternative: *Instead of providing copies, an organization may make the documents available on either its own or another organization’s website. If it uses this option, it has to: (1) provide an exact replica of the document as was filed with the IRS; (2) advise requesters how to access the forms on the web; (3) the site should charge no access fee and require no special software or hardware to download. Organizations that post this information on the Internet still must honor in-person requests to view the applicable documents.*

Permissible charges: *Tax-exempt organizations may charge a reasonable copying fee, up to \$1 for the first page and 15 cents for each additional page, plus actual postage costs.*

Penalties: *An organization that fails to comply with the new disclosure requirements may be subject to the following penalties:*

- Annual Information Return – Form 990 - \$20 per day for as long as the failure continues, up to a maximum of \$10,000 for each failure to provide an annual return.
- Exemption Application - \$20 per day with no maximum.
- An organization that willfully fails to comply with these public inspection rules can be subject to an additional \$5,000 penalty.

Private foundation exempt: *The new disclosure rules don’t yet apply to private foundations. They must still make a copy of their annual return available for public inspection at their principal office for a period of 180 days after publishing a notice of availability.*

Currently JAARS helps programs in Australia, Brazil, Cameroon, Gabon, Indonesia, Kenya, Papua New Guinea, Peru, and Tanzania.

(Land Transportation) JAARS helps its partners assess their travel challenges, advises on the best vehicles for their unique situations, and acquires and/or outfits vehicles for partner use. JAARS also trains partner staff-both overseas and at our headquarters in North Carolina-on how to safely drive and maintain motorcycles and four-wheel drive vehicles.

-Thousands of people come annually for short-term missions trips, museum visits, weekday tours, and "open-house" JAARS days.

JAARS also provides at its headquarters office space and support services to about 40 SIL media staff.

The collections of the museums at JAARS, which were acquired through purchases and contributions since the organization's inception, are not recognized as assets on the statements of financial position and, thus, are not reflected on the financial statements. Purchases of collection items are recorded as decreases in unrestricted net assets in the year in which the items are acquired or as temporarily or permanently restricted net assets if the assets used to purchase the items are restricted by donors. Museum was established in 1977 by SIL International to show appreciation to the people of Mexico and their president, Lazaro Cardenas (1934-1940). Besides the historical photographs, books in many languages, outstanding folk art and embroidered traditional costumes in the museum, there is a 1938 Chevrolet, a gift from the president, given out of the president's desire to help pioneer linguist W. Cameron Townsend, founder of Wycliffe Bible Translators, SIL and JAARS. The president welcomed the young Americans, whom Townsend was recruiting, and he endorsed the work of creating alphabets and providing translated Scriptures in the Mayan, Aztecan and other indigenous languages. - -
 - - - - - The Museum of the Alphabet, a project initiated by Dr. W. Cameron Townsend, took three years of research by Dr. Richard Pittman, followed by thirteen years of arduous work by artist and translator Kathryn Voigtlander and scores of volunteers. The museum traces the history of writing from it's beginning to the present. A metal sculpture of Mezrop Mastots of Armenia, a Sefer Torah scroll, a clay sculpture of Sequoia and many other artifacts from around the world add to the 75 colorful hand-painted displays. A computer display shows how useful this technology has been for modern linguists and Bible translators. - - - - - The museums educate visitors in the history of translating the Bible into many languages that people speak in their homes and villages. We hope these visitors will catch the vision for how important this mission is to bring peace to people's hearts and lives. People who have visited these museums have become missionaries, volunteers, and contributors to JAARS' mission.
